S.I. No. 3 of 2025

1. In exercise of the power in that behalf vested in him by section 28 of the Interpretation and General Provisions Ordinance 1993, and subject to the requirements set out in this Order, the Commissioner hereby delegates to the Commissioner's Representative the Commissioner's authority and powers to issue permits for the possession and use of diving equipment and underwater swimming equipment, pursuant to section 6(3)(h) of the Fisheries (Conservation and Management) Ordinance 2007.
2. The Commissioner's Representative may only issue the aforementioned permits to persons who will act in full compliance with –
 - (a) the Diego Garcia Local Coordinator Instruction 1700.2D, dated 24 January 2025 (the "Instructions"), and
 - (b) such other conditions as the Commissioner or Commissioner's Representative may impose.
3. The Commissioner's Representative will, as soon as practicably possible, notify the Commissioner of any amendment to, or cancellation of, the Instructions.
4. This Order shall come into force forthwith.
