CHAPTER F.3

In exercise of the powers vested in him by section 5(2) and section 15(1) of the British Indian Ocean Territory (Immigration) Order 2004, the Commissioner hereby prescribes that –

1. This Notice may be cited as the British Indian Ocean Territory (Immigration) Order 2004 Notice of Exemption 2017, RRBIOT c.F.3.

2. For the purposes of this Notice –

registered crew member means a crew member of the Marine Protection Vessel Grampian Frontier whose name and date of birth has been provided to the British Indian Ocean Territory Administration by North Star Shipping Ltd prior to the crew member's arrival in the Territory;

Territory has the definition assigned to it by the British Indian Ocean Territory (Constitution) Order 2004 and includes the Fisheries Conservation and Management Zone.

3. Section 5(1) of the British Indian Ocean Territory (Immigration) Order 2004 shall not apply to a registered crew member of the Marine Protection Vessel Grampian Frontier.

4. In supplying the names and dates of birth of crew members to the British Indian Ocean Territory Administration, North Star Shipping Ltd may provide these details either individually, or collectively.

5. If the Marine Patrol Vessel Grampian Frontier leaves the Territory as part of its operations and returns to the Territory without any change of crew, North Star Shipping Ltd will not be required to re-submit the names and dates of birth of each registered crew member.

6. Nothing in this Notice shall prevent the Commissioner or the Principal Immigration Officer from determining in relation to a particular person that the permit deemed in accordance with this Notice shall be cancelled, or otherwise withheld. In these circumstances, the provisions of the British Indian Ocean Territory (Immigration) Order 2004 relating to the issue or cancellation of permits and to matters consequential thereon or incidental thereto shall apply accordingly.

7. This Notice may be rescinded at any time.
