## RRBIOT c.G. 2

In exercise of the powers conferred by section 27 of the Post Office Ordinance 1967, His Excellency the Commissioner has made the following Regulations -

## Citation.

1. These Regulations may be cited as the Post Office Regulations 1994, RRBIOT c.G.2.

Postage rates.
2. Postage shall be chargeable on postal packets posted in the Territory at the rates specified in the Schedule to these Regulations.

## Maximum weights and dimension of postal packets.

3. A postal packet may not be transmitted through the post and will not be accepted for such transmission, if its weight exceeds 6 kilograms or if any of its external dimensions exceeds 50 centimetres.
