CHAPTER A.1

NOTICE

IT IS DIRECTED, pursuant to section 10(3) of the British Indian Ocean Territory (Constitution) Order 2004, that all laws made pursuant to section 10(1) of the said Order, shall be published in the *Gazette* in the following manner –

1. The text of the law shall be incorporated into an electronic version of the *Gazette*.
2. This electronic version of the *Gazette* shall also include, where publishing in the *Gazette* is required by law, the text of any –
 - a. Proclamation, Appointment, Notice or Direction made by the Commissioner;
 - b. Statutory Instrument or other subsidiary legislation; and
 - c. Order in Council that is applicable to the British Indian Ocean Territory.
3. Any other document that is not required by law to be published in the *Gazette* may also be included in the electronic version of the *Gazette*, if the Commissioner, or Administrator is of the view that it would be beneficial for it also to be published therein.
4. On the first page of the electronic version of the *Gazette* there shall appear the date on which that issue of the *Gazette* is published.
5. Subject to paragraph 6, a printed copy of the *Gazette* shall be displayed prominently on a notice board situated in Diego Garcia, to which those lawfully in the British Indian Ocean Territory have access, on the date that appears on the first page of that issue of the *Gazette*. A copy of this *Gazette* shall be placed in this position for a period of not less than six months.
6. If an issue of the *Gazette* is over 10 pages in length, a summary of the contents of the *Gazette* may instead be displayed prominently on the notice board

(in accordance with paragraph 5 above) with instructions as to where the complete issue of that *Gazette* may be inspected. Such inspection, if requested, shall be permitted within Diego Garcia, at a reasonable time, without charge.

7. The electronic version of the *Gazette*, or a link to it, may be included in the web pages or website utilised by the Administration of the British Indian Ocean Territory, or the Commissioner's Representative, to which a person may have access (either with, or without charge).

8. Any person may request a copy, either electronically, or in printed format, of an issue of the *Gazette*. This shall be provided to the person requesting such a copy, at a reasonable cost (if any) to be determined by the Administrator.

9. Each issue of the *Gazette* is to be published as frequently as the Commissioner or Administrator may determine.

10. If the Commissioner, or Administrator decides that there is a need to produce an issue of the *Gazette* at short notice, a *Special Gazette* or *Gazette Extraordinary* may be published in the manner described in paragraphs 1 to 7 above.

11. For the avoidance of any doubt, the date that appears on the first page of the electronic version of the *Gazette* (in accordance with paragraph 4 above) shall be the date on which any matter is published in the *Gazette*, unless it is proved that that issue was published on some other date.
